Dear Supervisor Maerten,

I would like to make you aware of a piece of legislation I have introduced in the Senate. The bill number is Senate Bill 1480 and pertains to permitting the town of Pendleton to create maximum speed limits that are not less than 45 miles per hour along Mapleton Road from the intersection with Campbell Boulevard through and including the intersection with Townline Road. This bill was requested by the town of Pendleton. I have enclosed a copy of this bill for your review. I anticipate the Assembly introducing the legislation in the near future.

Passage of this bill requires a home rule request. Four copies of the "Home Rule" form are required. The "home rule" form is now available online at www.nysenate.gov under the "About the Senate" tab. Please be advised that each form must be printed on 8 ½ x 14in. paper, have original signatures, and must be sealed in order to be accepted.

AN ACT authorizing the town of Pendleton, county of Niagara, to reduce the maximum speed limit along a certain portion of Mapleton Road in such town to 45 miles per hour

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. Notwithstanding any general, special or local law or code
2 to the contrary, the town board of the town of Pendleton, Niagara coun-
3 ty, may by local law, ordinance, order, rule or regulation establish
4 maximum speed limits at not less than forty-five miles per hour along
5 Mapleton Road from the intersection with Campbell Boulevard through and
6 including the intersection with Townline Road.
7 § 2. This act shall take effect immediately.
