Brief Description of Proposed Action (include purpose or need): The proposed action consists of the adoption of a Local Law by the Town Board of the Town of Pendleton, which is the sole SEQRA involved agency and therefore the lead agency. The Town Board proposes the legislative adoption of amendments to Chapter 247 (Zoning) of the Town Code, including amendments to the title of Chapter 247, Article IX, and the addition of a new § 247-72A governing Battery Energy Storage Systems (“BESS”), for the purpose of establishing uniform zoning, siting, safety, and permitting standards applicable to such systems within the Town. The proposed Local Law constitutes a purely legislative action. It does not authorize, approve, or involve any specific development project, land disturbance, or construction activity, nor does it grant any site-specific approvals. The Local Law establishes regulatory standards and procedures applicable to future BESS proposals, including definitions, zoning district applicability, permitting requirements, safety standards, and decommissioning obligations. The adoption of the Local Law will not, by itself, result in any direct physical changes to the environment. The proposed action does not create any new permitted principal or accessory land uses, does not increase permitted zoning or subdivision densities, and does not alter any existing zoning district boundaries.
